## **Important College Application Deadlines**

August 1, 2015 \*UC Application opens

Although the application for the UC system opens on August 1<sup>st</sup> a student is only allowed to view and fill in the application but not able to submit until **November 1<sup>st</sup> – November 30<sup>th</sup> 2014.** For the UC system if a student is interested in EOP there is a box that they **MUST** check off in order to be considered; there is no separate application.

August 1, 2015 Common application opens

Although the common app opens on August 1<sup>st</sup> there is no specific deadline as each school has its own application deadline.

August 7<sup>th</sup>,2015 ACT Deadline for September 12<sup>th</sup>, 2015 test date
September 18, 2015 ACT Deadline for October 24<sup>th</sup>, 2015 test date

October 1, 2015 Cal State Application Opens (www.csumentor.edu)

October 1, 2015 \*Cal State EOP (Educational Opportunity Program) App opens

\*The EOP (Educational Opportunity Program) application opens on the same day that the Cal State University application opens but students must make sure to mark that they are interested in applying for EOP in their application and then fill out the application for EOP as there are further requirements for it.

**November 6, 2015** ACT deadline for December 12<sup>th</sup>, 2015 test date

November 30, 2015 Cal State Application Closes

November 30, 2015 \*Cal State EOP application Closes

November 30, 2015 UC Application Closes

\*Although each EOP office at each Cal State has a different deadline in order for students to be considered for PRIORITY enrollment all students should be encouraged to submit their application by Nov. 30<sup>th</sup>.

IMPORTANT NOTE: It is important for students to remember to take their Math and English placement tests as early as possible. After speaking with college counselors from different Cal States their number one concern was a student not taking these placement exams at earlier dates. January 1, 2016 FAFSA Opens at 12:00am

**January 8, 2016** ACT Registration Deadline for February 6<sup>th</sup>, 2016 test date

March 1 – 31, 2016 UC/CSU Admissions notifications

March 2, 2016	*FAFSA Deadline
March 2, 2016	*Cal Grant GPA Verification Form Deadline
March 2, 2016	California Dream Act Application Deadline
March 4, 2016	ACT deadline for April 9 <sup>th</sup> 2016 test date

<sup>\*</sup>The final FAFSA deadline is June 30<sup>th</sup>, but the student will not qualify for state aid and the portion of federal aid he/she may receive will be significantly diminished.

May 1, 2016 National College Decision Day

July 2016 Check emails regularly and keep track of paperwork that must be

submitted.

August 2016 Colleges usually send out their first tuition bills during the first

week of August.

September 2, 2016 Cal Grant Deadline for Community Colleges
September 19, 2016 FAFSA Updates and Corrections Deadline

<sup>\*</sup>Although the Cal Grant deadline is on March 2<sup>nd</sup> for students who are not attending a four year institution the second deadline is September 2<sup>nd</sup> for community colleges. Students should check with their counselor to see if their Cal Grant GPA Verification Form is submitted automatically by their school.
